This Memorandum of Understanding has been agreed to between The American College (Autonomous), Tallakulam, Madurai – 625 002, herein after called First Party and Friends of Madurai (FOM), 3/422, Thiruvalluvar street, Dinamani Nagar, Madurai – 625018, herein after called Second Party.

In a true and warm spirit of understanding and co-operation, we the undersigned after a thorough discussion have decided to carry out the following provisions in reciprocity which will pave way for the academic prosperity of The American College, Madurai – 625002 and the research and social welfare activities of Friends of Madurai (FOM), Madurai - 625018.

The Memorandum of Understanding by The American College and Friends of Madurai witnessed as under:

- Students of The American College may be provided with "Practical Training Program" for horticultural techniques, by experts of Friends of Madurai (FOM), Madurai to enhance their practical capabilities and develop aptitude for self employment.
- 2. The **Professional Expertise** of Friends of Madurai (FOM) may be utilized to enhance the academic standards of students of The American College by accommodating them in the projects of Friends of Madurai (FOM) without any financial commitment to Friends of Madurai (FOM).
- 3. The experts from Friends of Madurai (FOM) may participate as **resource persons** in the academic and extension programs for students conducted by The American College.
- 4. The facilities available at The American College may be utilized by Friends of Madurai (FOM) for their research and extension activities without any financial commitment to the college and the management.
- 5. To jointly organize short-term training programs, seminars, conferences, or workshops on topics of mutual interests and invite each other's experts/ staff to participate therein.
- 6. The American College and Friends of Madurai (FOM) agree to help identify and invite faculty members from other institutions to participate in talks, conferences, workshops and short-term courses.

Duration of the Agreement

This agreement will take effect from the date it is signed by representatives of the two institutions. It will remain valid for two years, and may be continued thereafter after suitable review and agreement.

Arbitration and Termination

In the event of any dispute, difference or disagreement arising out of or in connection with this agreement, the matter will be referred in the first instance to S. Ahil Rishi Rajasekaran, Founder, Friends of Madurai, Madurai and Principal & Secretary of The American College. They will endeavor to resolve the matter in a spirit of interdependence, mutual respect, and shared responsibility.

Either party may terminate the agreement by giving written notice of not less than 90 days' notice to expire on the proposed termination date.

The two institutions mutually agree upon and sign this document with their full consciousness, understanding and acceptance in matters mentioned as above.

The legal dispute of this Memorandum of Understanding will be at the jurisdiction of Tamil Nadu. Signed at Madurai on the 3rd day of March in the year 2022
