Memorandum of understanding (MOU)

For Research and Academic Co-operation

between

and

This memorandum of understanding has been agreed to between The American college, Community college (Autonomous), Tallakulam, Madurai- 625002, represented by its Principal & Secretary hereinafter called First Party and Muthupandi Ornamental Fish shop, Maruthupandiar street, Angayarkani colony, Athikulam, Madurai-625107 represented by its proprietor Mr. Muthupandi herein after called second party for Academic Co-operation, Research and Placement.

The American College and Muthupandi Ornamental Fish Shop recognize the strength in education, practical training and research in accordance with their individual mission and objective to foster and indentify their areas of mutual interest for college and Corporate Institute tie-up.

Now therefore Memorandum of Understanding by The American College and Muthupandi Ornamental Fish Shop witnessed as under:

- a) To exchange information on local demand and Commercial opportunity and educational programmes.
- b) To exchange information on teaching and learning materials relevant to their education and research programmes.
- c) To jointly organize short- term training programmes on topics of mutual interest and to invite each other's faculty/staff to participate therein
- d) To jointly organize seminar, conferences, or workshop on topics of mutual interest to invite each other's faculty to participate therein.
- e) To provide hands-on experience and internship training in Ornaments fish culture for the students of The American College- Community College of The American College.
- f) To provide placement opportunity for the students of The American College- Community College of The American College.
- g) To invite the experts from Muthupandi Ornamental Fish Shop for delivering guest lecturers act as members of Board of Studies in Aquaculture and for evaluation.

Every year the partners will evaluate the number and extent of activities and, where it is considered necessary, agree on any adjustment that should be made in the subsequent year to redress any imbalance.

Student Exchanges

The American college and Muthupandi Ornamental Fish Shop agree that student's exchanges shall be confined to Diploma, undergraduate, post- graduate and research student exchanges between both the institutions for doing their internship, course- work and other research work as well training.

Joint conferences, Workshops and short- term courses

The American College and Muthupandi Ornamental Fish Shop agree to help identify and invite faculty members from other institutions to participate in conferences, workshop and short- term courses. The terms and conditions for such participations will be worked out by mutual agreement between the invited faculty member(s) and the institutions extending such as invitation. When a faculty member visits the other institution on invitation or as part of such joint activity, then such a visit will be classified as such, and handled as per the rules of the respective institution

Duration of the Agreement

This agreement will take effect from the date it is signed by representatives of the two institutions. It will remain valid for five years, and may be continues thereafter after suitable review and agreement.

Arbitration and Termination

In the event of any dispute, difference r disagreement arising out of or in connection with this agreement, the matter will be referred in the first instance to Muthupandi Ornamental Fish Shop and Principal & Secretary of The American College. They will Endeavour to resolve the matter in a spirit of interdependence, mutual respect, and shared responsibility.

Either may terminate the agreement by giving written notice of not less than 180 days to expire on the proposed termination date. Agreements for termination must include provision by Muthupandi Ornamental Fish Shop and The American College for continuing students to complete their studies and the period of notice should take account of any re- assessment that may be outstanding.

Intellectual property

The American College and Muthupandi Ornamental Fish Shop agree to respect each other's rights to intellectual Property. Further, the intellectual rights that arise as a result of young collaborative research or activity under this agreement will be worked out on a case- by- case basis, and will be consistent with officially laid down IPR of the two institutions.

Publicity Materials

Muthupandi Ornamental Fish Shop and The American College will not include the name, visual identify, crest or logo of the other institution in any advertising or publicity material without that institution's prior approval on a case- by- case basis. The format and style of any visual identify and logo, and advertising and publicity material relating to the Agreement and any guidelines for their use, and responsibility for funding such material must be agreed to jointly by Mr.Muthupandi and Principal & Secretary, The American College prior to the appearance in the media.
