



- e) To provide hands-on experience and observation internship training in all areas of Medical Laboratory Technology for the students of B. Voc /M. Voc Degree Programmes of The American College.
- f) To provide placement opportunity for the students of B. Voc /M. Voc Degree Programmes of The American College if required by Vadamalayan Hospitals Pvt. Ltd, Madurai.
- g) To participate in curriculum designing and evaluation.
- h) To invite the experts from Vadamalayan Hospitals Pvt. Ltd, Madurai for delivering guest lectures and act as members of Board of Studies in Medical Laboratory Technology.

Every year the partner will evaluate the number and extent of activities and, where it is considered necessary, agree on any adjustment that should be made in the subsequent year to redress any imbalance.

#### **Exchange Service**

#### **Joint Conferences, Workshops and short – term courses**


